

CITY OF CENTERTON SPECIAL CITY COUNCIL MEETING VIA ZOOM OCTOBER 27, 2022

(1) Roll Call -

The Special City Council Meeting was called to order by Mayor Bill Edwards at 6:00p.m. Those Present and answering roll call were Mayor Bill Edwards, Keith Higginbotham (via Zoom), Josie Reed (in Person) and Amy Rochette (via Zoom). Misty Elam (via Zoom), and Darren Warren (via Zoom) and Justin Cowgur was absent. Those present and not answering role call were City Attorney Brian Rabal (via Zoom), and Financial Director Carl Rabey.

(2) Ordinance -

• Ordinance 2022-84 - AN ORDINANCE WAIVING BIDDING REQUIREMENTS FOR THE PURCHASE OF A 2023 CHEVROLET TAHOE FROM SUPERIOR AUTOMOTIVE, SILOAM SPRINGS, ARKANSAS FOR THE CENTERTON POLICE DEPARTMENT.

Mayor Edwards addressed the Council, stating that this Ordinance is to waive the bidding requirement for a 2023 Chevrolet for the Police Department, at a cost of \$47,142.00. He stated this was to replace a 2015 Chevrolet Tahoe with a major engine problem. A copy of the quote for the truck was contained in the Council's Dropbox packet.

City Attorney Brian Rabal read the emergency clause. Keith Higginbotham made a motion to adopt the emergency clause, 2^{nd} by Josie Reed.
